1. This Agreement is for the use of BOAT PARKING rights only and such BOAT PARKING area is to be used at the sole risk of the boat owner. The Town of Deep River shall not be liable for the care, protection, loss or damage of the boat or its gear, equipment and contents. The boat owner indemnifies and holds the Town harmless against any loss, claim or suit arising out of the use of BOAT PARKING AREA, boat, parking lot and its associated structures and/or equipment.
2. This Agreement shall be in effect unless terminated as a result of the following:
 - (a) The destruction of the parking facilities by storm, fire or calamity.
 - (b) In the event that the boat captain/operator shall make a bona fide sale of the boat listed in this Agreement.
 - (c) By breach or default as provided in paragraph (3) below.
3. Owner agrees to comply with all Regulations, and if such are breached or defaulted the Town has the right to terminate this Agreement immediately, and to take possession of the BOAT PARKING space.
4. Waiver of any conditions by the Town shall not be deemed to be a continuing waiver.

CORPORATION OF THE TOWN OF DEEP RIVER WINTER PARKING REGULATIONS



It is the desire of the Corporation of the Town of Deep River to provide a high level of service, safety and convenience, equitably to all users. To achieve this, it is mandatory that all renters abide by the following regulations while your boat is parked within the Marina upper Parking lot.

1. Proof of liability insurance is required by all users.
2. Only the registered boat owner may use the space assigned.
3. Boats shall be secured to the trailer or platform with fully adequate lines or chains. The Recreation Department may ask owners to replace inadequate or unsafe lines/chains that could result in damage to other boats.
4. Boat owners are responsible to ensure that they do not infringe on the rights of other users.
5. Sail boat owners are required to tie back halyards and lines.
6. The Recreation Department does not provide supervision or security of any boat in the winter parking space.
7. Payment is required within 30 days of invoice. Failure to make payment will result in termination of agreement and the Town will have the right to take possession of the BOAT PARKING space.
