NOTICE OF COUNCIL'S INTENTION TO PASS A NEW COMPREHENSIVE ZONING BY-LAW WITH MODIFICATIONS

The Council of the Town of Deep River met on April 1, 2020 to consider public input that has been received on the Town's proposed new Comprehensive Zoning By-law. One of the public submissions received requested that provisions be included in the new Zoning By-law for Small Modular Reactors (SMRs) and Very Small Modular Reactors (VSMRs). SMRs are recognized in the Town's Official Plan as a potential initiative for achieving the Town's vision as a pioneer in alternative and renewable energy. Therefore, it is proposed that the Town's new zoning by-law be modified to include the following provisions for SMRs and VSMRs:

1) Add to Section 2.0 Definitions:

- SMALL MODULAR REACTOR (SMR) means a nuclear reactor regulated by the Canadian Nuclear Safety Commission that generates greater than 15 megawatt electric (MWe) per facility, but less than 300 megawatt electric for the purpose of supplying heat and/or electrical power generation into electrical grids.

- SMALL MODULAR REACTOR, VERY (VSMR) means a nuclear reactor regulated by the Canadian Nuclear Safety Commission that generates not greater than 15 megawatts electric (MWe) per facility, for the purpose of supplying heat and/or electrical power generation into electrical grids.

VSMRs will be considered as a public utility in accordance with Section 3.23 Public Services of the Zoning By-law. SMRs will be considered on a case-by-case basis and require a Zoning By-law Amendment.

Additional information on this matter may be reviewed on the April 1, 2020 Council Meeting Agenda Package. The Draft Zoning By-law, as modified, will be received by Council at their meeting on April 8, 2020. A decision on the new Zoning By-law is scheduled for the Council Meeting on April 22, 2020.

DEEP RIVER FIRE DEPARTMENT

All outdoor fires in Ontario restricted during the COVID-19 pandemic

The province of Ontario government is taking action to protect people and communities from the risk of preventable human-caused fires and to ensure that the province's emergency response system remains strong during the COVID-19 outbreak. Starting April 3rd, Ontario's entire legislated fire region will be designated a Restricted Fire Zone. Residents who live in an area with a restricted fire zone cannot have an outdoor fire—this includes burning of grass, debris and campfires, even when using an outdoor fire grate, fireplace or fire pit.

Minister of Natural Resources and Forestry and local MPP John Yakabuski says during this very challenging time when we are fighting the spread of the virus, our number one priority is the health and safety of the people of Ontario. He adds they're putting these important preventative measures in place now to ensure that our emergency responders are able to focus their efforts where they are needed most.

This restriction will remain in place until Ontario's ability to respond to emergencies is no longer impacted by the COVID-19 outbreak. Local municipalities are working to update their websites with information for residents.
