Serving Our Community

There were significant changes in 2021 for the Deep River Police Service. The Covid-19 global pandemic continues to affect all aspects of our lives and how we conduct business. Our Police Service continued to focus on how to best protect, serve and support our members as well as members of our community. Contingencies were put in place to manage potential covid related illnesses while remaining fully operational. New protocols including standing orders restricting walk-in traffic and managing to reduce the potential of workplace outbreaks were developed. The DRPS hired an experienced constable to maintain our current complement of sworn officers. The DRPS continued its tradition of providing adequate and effective policing to the citizens and visitors of Deep River. In addition to investigating crimes, enforcing traffic and responding to calls for service we also delivered an assortment of other services that our residents continue to expect. Examples such as foot patrol, vacant house checks and commercial property checks to name a few. Overall staffing for 2021 consisted of nine full time uniform members, a part time uniformed officers, one civilian member, and two special constables. Our Service continues to provide free criminal record checks to individuals volunteering in our community.




Structure of the DRPS

Governance: The Deep River Police Service was formed in conjunction with town's inception in 1957. Governance of the DRPS is provided via the three-member Deep River Police Service Board. In 2021, the DRPSB consisted of Chair Ms. Tracy Russell, Mayor Sue D'eon and Ms. Kelly Lapping. Mr. Christian Kaiser is the Board Secretary. The Board is responsible for the provision of adequate and effective police services in the municipality.

Administration: Chief of Police Dean Duchrow has primary responsibility for the administration and operations of the Deep River Police Service. He also provides operational backup and coverage on occasion.

Administrative assistant Michelle Russell supports the Chief of Police.



Member Profiles



Anne Ray was hired with the Toronto Police Service in December 2006. She continued her career with Toronto as a primary response, community response and criminal investigations officer. In 2014 Anne became a Constable with the Deep River Police Service and currently holds the rank of Acting Sergeant. She is the Coordinator of Human Trafficking, Major Case Management, DNA, Sex Offender Registry, and is qualified in administering standardized field sobriety testing, as a breath technician, scenes of crime, coach, bike trained, violent risk threat assessment, and VICLAS officer. Anne is well versed and trained with several Ontario Police College accredited courses and is actively involved in organizing community events as the Vice President for the Deep River Police Association.



Jessica Brum was a constable with the Ottawa Police since April 2019 and joined Deep River Police Service in January 2022. Jessica is a sexual assault response officer (SARO) and is trained in mental health first aid and standardized field sobriety testing.



Constable Michael Slattery started his policing career with the Nishnawbe Aski Police Service in 2018. While with NAPS Constable Slattery was posted to Kasabonika Lake, Wunnumin Lake and Kingfisher Lake first nations. While serving with NAPS Constable Slattery was highly engaged with the community and was focused on building strong relationships between the community and police. Constable Slattery felt a passion and desire to come back to the Ottawa Valley and serve his community. In 2020 Constable Slattery was hired by the Deep River Police Service. Constable Slattery is currently the DRPS Hospital Liaison Officer. In this role Constable Slattery routinely speaks with hospital staff and management to ensure the safety of staff and patients. Constable Slattery is passionate about his ongoing service to the community of Deep River.

Member Profiles



In 1985 Andrew Gagne was hired as a Probationary Constable with the Pembroke City Police Service. He worked his way through the ranks doing various jobs like Community Service Officer and Court Officer. In 1994, he was assigned to the Criminal Investigation Branch. He performed as a plain clothes Detective until 1998, when he returned to Uniform to be an Acting Sergeant. In 2001, he was assigned to run the Courts, when the new Provincial Court was built in Pembroke. In 2010 he was promoted to the rank of Sgt. In 2013, the Pembroke Police were amalgamated with the Upper Ottawa Valley OPP. He joined the OPP and continued as a Patrol Sergeant until 2015, when he was assigned as an Administrative Sergeant. In 2016, he did an acting Staff Sergeants Position. In February of 2017, he retired from the Ontario Provincial Police and was offered employment as a Part-Time First-Class Constable with the Deep River Police. He remained in this role, until being asked to fill a full time, acting Sergeant's role. In September of 2021, he started that role until January 31st, 2022. He has since returned to his role of part-time Patrol Constable where he continues to serve the people of Deep River. In March of this year, he celebrates 37 years of policing!



Matthew Barker has spent his entire policing career as a member of the Deep River Police Service and currently holds the rank of Acting Sergeant. Along with the duties of a patrol Sergeant, Matt is also responsible for all in-service training which consists of instructing use of force, firearms and tasers. Matt ensures officers receive monthly training and provides updated information on the most recent legislative changes. Matt is also a qualified breath technician, and an Immediate Action Rapid Deployment instructor. He is responsible for ordering *uniforms, vests, use of force and vehicle equipment*.



Michelle Russell has been the Administrative Assistant for the Deep River Police for the past 4 years. Michelle previously worked for the Ontario Provincial Police for 3 ½ years in the CDE and ViCLAS departments before moving to Deep River in 2018. Michelle is responsible for receiving and directing inquiries to the Officers and Chief of Police. Some of her responsibilities include maintaining court files, court calendars, occurrence files, fingerprinting, fingerprint records, criminal record checks and vulnerable sector searches. She is also the Freedom of Information (FOI) Coordinator responsible for completing any requests in accordance with the Freedom of Information Act. Commissioner of Oaths, maintaining routine correspondence, preparing and submitting reports and compiling statistics.

Dave Newell is the Deep River Police Coordinator for the Violent Crime Linkage Analysis System (ViCLAS) and the Ontario Sex Offender Registry. Other areas of responsibility are Scenes of Crimes Officer, DNA collections, Property Management Officer, Major Case Management data entry, bike patrol and a member of the Renfrew County Situation Table. Dave has also been involved in a supervisory role as an Acting Sergeant. Dave was also able to participate in the Provincial Operation, Northern Spotlight (Human Trafficking Initiative).



In April 2001 Rob Medeiros started his policing career as a general uniform patrol officer with the DRPS. Rob is a recognized coach officer and a qualified breathalyzer technician. Rob is certified as a use of force instructor and firearms instructor. He is certified as a Glock/Colt C-7/8 weapons/ Smith and Wesson armourer. He was awarded the OACP award of excellence for traffic safety in 2014 and is the Traffic Management Officer for the Dept.



Constable Amanda Brela began her policing career with the Deep River Police in 2009. Since that time Constable Brela has taken a variety of courses and training including but not limited to, Youth Officer, Investigative Interviewing, Sexual Assault Investigations and Domestic Violence Investigations. Constable Brela is currently the departments Domestic Violence Coordinator and is responsible for reviewing all Domestic Violence related occurrences.

Constable Marek Brela started his policing career with Peel Regional Police in 2000. He then accepted employment with the Canadian Armed Forces as a Military Police officer and was posted to Garrison Petawawa. In 2009, Marek Brela accepted employment with Deep River Police where he currently holds the rank of constable. Marek is assigned to front line general patrol and is the Deep River Police Services Community Service Officer. He has attended the Ontario Police college and completed a variety of courses including Investigative interviewing, Fraud investigations and Youth officer course to name a few.

Road Safety & Enforcement

Officers on general patrol incorporate enforcement of traffic violations as part of their duties. We strive to keep our community safe on the roads in town as well as on Highway 17. Enforcement is subject to many factors including weather, volume of traffic, and officer availability. Over the course of the year, the majority of HTA charges were related to speeding violations. Seasonably, summer is the highest enforcement period, a result of better weather/driving conditions and increased volume of traffic.




Community Patrol and Crime Prevention

By establishing a highly visible presence in the community, the Deep River Police Service strives to ensure that our residents know that local police officers are available and accessible when needed. The Deep River Police maintain the ability to respond to incidents and radio calls in a safe and timely manner.

In addition to vehicle and foot patrols, officers conduct regular checks of downtown commercial properties, vacant houses, recreational properties, schools during supervised/unsupervised hours, and highway businesses. During the 2021 cycling season, Deep River Police also conducted bicycle patrol.

As a means of crime prevention, the Deep River Police engaged in the following activities:

- Monthly Renfrew County situation table meetings
- > Posted weekly North Renfrew Times articles on crime prevention
- Successfully completed violent threat risk assessment training
- > Presented via zoom to the Deep River senior friendship club on frauds and scams
- Conducted Halloween safety presentation at local school
- Information shared on the Deep River Police Facebook page during the week of November 7-13th for crime prevention week
- > Utilized Crime stoppers to receive and follow up on tips
- Recognized and posted on Facebook information in support of Gender based violence from November 25 to December 10 which coincides with International Day for Elimination of Violence Against Women and World Human Rights Day





CSO Report

As the challenges of the global pandemic continued in 2021, the Deep River Police Service continued to serve the community in various ways.

Weekly articles were submitted to the North Renfrew Times (NRT) for publication, providing readers with information on a variety of topics such as Cyber Security, Child Safety Seats, Winter Driving, Lock it or Lose it, and Impaired Driving.

The DRPS continued to collaborate with Crime Stoppers and investigate public tips throughout the year.

Officers participated in monthly round table meetings with other agencies of Renfrew County in efforts to identify at risk individuals within the community.

A presentation was conducted by the courts in March to inform Officers of current cases in the Deep River area. In addition, they provided updated information on dealing with probationers and parolees and gave a presentation on Extra Judicial Measures and Sanctions.

Officers took part in violent threat risk assessment (VTRA) online courses, which are aimed to establish how to best assist a student's behaviour to prevent violence or self-injury.

In April, the second-year report for the Community Safety and Policing grant was submitted to the Ministry for approval.

RCMP provided DRPS a Counterfeit training package for Canadian and US currency which was used to inform local businesses on how to detect counterfeit currency.

DRPS gave a tour of the police station to a group of children attending day camp at the Deep River Arena during the summer. The children were given the opportunity to observe the operation of a Police Cruiser and speak directly to on duty Officers.

Officers performed bicycle patrols of Deep River focusing on trails, beaches, and walking paths not generally accessible by vehicle.

In September, Officers took part in decorating smile cookies at the local Tim Hortons. They also attended the Deep River and District Hospital to donate DRPS water bottles to all the staff as a sign of appreciation.

The Deep River Police Association held a BBQ outside the police station. A dunk tank was rented to allow residents to attempt to dunk a Police Officer. Donations were accepted for the North Renfrew Family Services.

Members of the Deep River Police Service participated in the Police Officer Memorial Run from Pembroke to Petawawa. The run was approximately 16 km. The purpose was to bring awareness and recognition to fallen police officers in the line of duty.



CSO Report (con't)

In October, the Deep River Police conducted a Halloween safety presentation to St Mary's grade 1-4 students. The presentation focused on Halloween safety topics such as: what to do when a child is lost, make sure costumes fit property and how to navigate the streets with traffic.

During the week of November 7-13, the Community Service Officer (CSO) for Deep River Police posted many topics on Facebook in recognition of Crime Prevention month. Topics consisted of fraud, counterfeit currency and lock it or lose it and were posted on Facebook to educate and inform the public.

On November 11, members of the Deep River Police, the Deep River Police Association, and other EMS agencies participated in a local Remembrance Day ceremony. Officers placed a wreath at the cenotaph and attended the ceremony at the Deep River Legion.

In December, members of the police service participated in the annual Cram the Cruiser event held in front of the local Valu-Mart. As a result of the event, the food bank received 71 large boxes of food and several household products and \$2,083.90 in donations.

During 2021, the CSO conducted zoom presentations to the Senior Friendship Club on frauds and scams. These presentations were done in collaboration with a member of the local internet provider and focused on how to safeguard personal information on computers.










Assistance to Victims

Assistance to Victims

A priority of the Deep River Police Service is to ensure support for those who've been victimized as a result of a crime or tragic event. A vital means of providing support is through a referral system to address their needs and reduce the potential of revictimization.

As a result of Police interaction, individuals and families are directed with appropriate community-based referrals through collaboration with Victim Services of Renfrew County, Victim/Witness Assistance Program, the Mental Health Crisis Team and Family and Children Services.

Through education and awareness, the DRPS provides victims with information pertaining to safety planning to effectively reduce the risk of being re-victimized.

DRPS provides the community with tips on Crime Prevention Through Environmental Design (CPTED) by providing strategies to reduce the risk of residents falling victim to criminal behavior. Suggestions include unobstructed views around their home or businesses, better lighting, and removing any articles that could benefit the perpetrator in committing a crime.


The DRPS is an active member of the Domestic Violence Community Coordinating Committee as well as the Renfrew County Domestic Violence Advisory Committee.








Cost of Policing

Our organization is a cost-effective service, directly accountable at a local level. As a partner in the town's financial strategy, we participate in the town's budgeting process, and are aware of the need to be fiscally responsible to the residents of Deep River. See below graph for budget comparison. Revenue for the service is acquired through grants and miscellaneous revenues such as criminal record checks. Revenues in 2021 included a grant of \$22 500 for community policing through the Ministry of Community Safety and Correctional Services, a grant of \$6 872 to enhance regular Reduce Impaired Driving Everywhere (R.I.D.E) programs and approximately \$131 725.00 in revenue from the criminal record checks. This amount can vary significantly depending on demand. The Deep River Police continue to provide free criminal record checks for volunteers in Deep River. The established operating budget for 2021 was \$1 467 311.44. The year end result showed an actual expenditure of \$1 480 001.94. A difference of \$12 690.50. A review of the budget indicates that most sections were within the projected allotments. Our budgeting for 2021 remained realistic, accountable, and provided the means for adequate staffing and resources.
