
• ELECTRONIC WASTE

ITEMS THAT WILL NOT BE PICKED UP

Household garbage, recyclable materials, cardboard, construction and demolition material of any kind, furniture, mattresses and box springs, carpets, large tree limbs/trunks/stumps, plastic toys, tires or household hazardous waste (HHHW) such as motor oil, gasoline, paint cans, batteries, antifreeze, etc., and any other items not listed in the accepted items list.

Hydrant Flushing Notice



Flushing is part of a routine maintenance program that is necessary to maintain the integrity of the water system, remove sediment from water mains, verify the proper operation of hydrants and valves, and maintain firefighting capability.

Residents throughout Town may experience a drop in water pressure and water may be rusty or cloudy due to flushing of the distribution system. If you have rust-coloured water please run your COLD WATER TAPS ONLY (suggested taps: outside hose, bathtub or laundry tub) until the water is

Deep River Fire Department

A reminder to residents that 2022 recreational and open-air burning permits are available at the Town Hall. Permits are required for permanent and temporary fire pits. Residents must adhere to the conditions outlined on the permit and in accordance with By-law 25-2020. Burning without a permit and/or failure to follow the permit conditions is unsafe and may result in a fine

"Every person who sets or maintains an Open-Air Fire shall do so no earlier than two (2) hours before sunset, and all persons shall extinguish the Open-Air Fire no later than two (2) hours after sunrise, unless approval is received from the Chief Fire Official or designate."


