10.1. Madawaska Valley – Support for Forestry Industry

**MOVED THAT** the following resolution from the Township of Madawaska Valley be endorsed by the Council of the Corporation of the Town of Deep River:

WHEREAS the Township of Madawaska Valley has received notice of two devastating impacts to the forest industry both of which will have serious affects on our local economy, both in the present and the future;

**WHEREAS** the Wood Turtle Habitat Regulation has received Cabinet level approval;

AND WHEREAS the wood turtle resides in Algonquin Park;

**AND WHEREAS** the Wood Turtle Habitat Regulation has not been filed as regulation;

**AND WHEREAS** there has been no socio-economic assessment completed in response to the determination of wood turtle habitat as identified in the Wood Turtle Habitat Regulation;

**AND WHEREAS** there is no scientific information to support the Wood Turtle Habitat Regulation;

**AND WHEREAS** there was only a single public consultation event in Toronto on the Wood Turtle Habitat Regulation, with no consultation occurring in rural communities, particularly in affected communities such as the Township of Madawaska Valley;

**AND WHEREAS** Ontario Parks Board has contended a proposed expansion of the protected zones within the park – Lightening the Ecological Footprint of Logging within Algonquin Provincial Park;

**AND WHEREAS** by doing this our provincial government has proposed to reduce the area of logging within Algonquin Park;

**AND WHEREAS** the Ministry of Natural Resources (MNR) and the Algonquin Forestry Authority (AFA) have conducted a joint wood supply analysis to assess the impacts on the local forest industry;

**AND WHEREAS** the results of this assessment were unanimous in concluding that the proposed expansion of the protected zones within the park would have severe impacts on fiber supply and the local forest industry;

**AND WHEREAS** the harvesting operations in Algonquin Park are conducted according to world-class standards and are governed by one of the most comprehensive and stringent management systems in the world;

**AND WHEREAS** no credible scientific rationale exists to support the reduction in the area logged in Algonquin Park;

**AND WHEREAS** the Ministry of Natural Resources committed to a provincial baseline wood supply of 24 million cubic meters in Room to Grow – Final Report of the Ontario Forest Accord Advisory Board on Implementation of the Accord;

THEREFORE BE IT RESOLVED THAT it is the position of the Township of Madawaska Valley that the forestry industry and the backcountry experiences in Algonquin Park currently co-exist to the benefit of both; and

**FURTHER BE IT RESOVED** that the Ministry of Natural Resources, the Algonquin Forestry Authority, and the Ontario Parks Board cease the Lightening the Footprint initiative;

**BE IT FURTHER RESOLVED THAT** it is the position of the Township of Madawaska Valley that the Wood Turtle Habitat Regulation should be immediately withdrawn prior to filing and returned to Cabinet, accompanied by a comprehensive socio-economic impact assessment for revision;

**FURTHER BE IT RESOLVED** that a new Wood Turtle Habitat Regulation should not be developed until there is a comprehensive and direct consultation with the rural communities that will be directly impacted by the regulation including the Township of Madawaska Valley;

**BE IT FURTHER RESOLVED** that, if the Wood Turtle Habitat Regulation has been filed, that the government of Ontario should immediately withdraw the regulation and return it to Cabinet, accompanied by a comprehensive socioeconomic impact assessment for revision;

**BE IT FURTHER RESOLVED THAT** revisions to the Wood Turtle Habitat Regulation should not be completed until there is comprehensive and direct consultation with the rural communities that will be directly impacted by the regulation, including the Township of Madawaska Valley.
