9.1 Ottawa River Heritage Designation

WHEREAS in a resolution adopted on April 30, 2008, the Council of the County of Renfrew unanimously supported the designation of the Ottawa River as a Canadian Heritage River, in accordance with the Canadian Heritage Rivers Systems;

AND WHEREAS historically the Ottawa River represented a vital waterway for our First Nations Communities and the designation of the Ottawa River as a Canadian Heritage River is fully supported by our First Nations Communities;

AND WHEREAS, the Ottawa River played an integral role in many of the key events constituting Canada's history, thereby facilitating the development of Canada as a Nation;

AND WHEREAS a 100 person volunteer committee has worked for 8 years on this project committing thousands of volunteer hours and widespread consultation with numerous stakeholders has occurred;

NOW THEREFORE the Council of the Corporation of the Town of Deep River respectfully requests Prime Minister Stephen Harper to consider and ensure that the designation documents are immediately approved, thereby allowing the Ottawa River to be recognized as the great historic river that it truly is.

AND FURTHER THAT this resolution be circulated to the Honourable Jim Prentice, Federal Minister of the Environment and Cheryl Gallant, MP, Renfrew-Nippissing-Pembroke.

9.2 Roadside Parks

WHEREAS the Trans Canada Highway 17 is a major transportation link which runs throughout our municipality with a tourist traffic volume which increases dramatically during the warmer months;

AND WHEREAS changing weather patterns have resulted in increased traffic both earlier and later in the year, outside of normal park opening times;

AND WHEREAS the road-side parks are opened for a short length of time, limiting the availability of washroom and rest stop facilities requiring travellers to use local business facilities often without corresponding compensation;

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Deep River does hereby request that the provincial government commits to reviewing the current structure of its road-side park and rest area schedule with a goal towards increased flexibility depending on changing weather patterns and increased demand;

AND FURTHER THAT this resolution be forwarded to Premier McGuinty, our local MPP – John Yakabuski, John Baird - Minister of Transport, Infrastructure and Communities, Kathleen Wynne - Ontario Minister of Transportation and the Association of Municipalities of Ontario.

9.3 Municipal Liability Reform Working Group

WHEREAS the Association of Municipalities of Ontario has recently presented a report from their Municipal Liability Reform Working Group;

AND WHEREAS that document has effectively demonstrated the effects of joint and several liability on municipalities in some key areas including building inspections, the scaling back of services and motor vehicle and road safety;

AND WHEREAS other governments worldwide have also begun to make changes to their legislation and for the same reasons;

AND WHEREAS AMO's document has revealed that the origin of joint and several liability insurance has never been an explicit legislated intent of common law jurisdictions;

AND WHEREAS the Council of the Corporation of the Town of Deep River support the position of AMO on this issue and agrees that Ontario municipalities ought not to be insurers of last resort, targeted deliberately in some instances because of joint and several insurance;

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Deep River does hereby call on the Federal and Provincial governments to reform joint and several liability insurance as it exists today, with a particular regard for the impact it has on 'deep pocket' property taxpayers and their communities;

AND FURTHER THAT this resolution be forwarded to the office of the Prime Minister, our local MP Cheryl Gallant, our local MPP John Yakabuski, the Premier of Ontario, The Provincial Leader of the Opposition, the Federal Leader of the Opposition, the Federal and Provincial Leaders of the NDP and the Association of Municipalities of Ontario (AMO).
