AND FURTHER THAT the costs of approximately \$1,108.53 plus HST for the brine pump, and \$500.00 plus HST for labour (for both the brine pump and the compressor overhaul) be funded from the Miscellaneous Tools, Equipment & Materials and the Miscellaneous Equipment Maintenance accounts in the operating budget for 2011;

AND FURTHER THAT the cost of approximately \$6,500.00 plus HST for the overhaul of the compressor be funded from the annual Arena Capital Maintenance account in the capital budget for 2011.
