6.1 A/O List Review

6.2 2011DR005ISS – Authorized Requester Agreement MTO

Dawn Recoskie, Deputy Clerk, provided an overview of her report. By renewing the agreement the Town will continue to receive revenue from the Provincial Offences Court for parking infractions. A by-law was prepared and passed later in the meeting.

6.3 2011JW006ISS – Gasmann Rezoning and OP Amendment

John Walden, Manager of Planning & Development, provided an overview of his report. Mr. Walden explained there was an oversight in the OPA process that resulted in the Notice of Adoption not occurring in the required timeframe which is why the by-law for the Official Plan amendment is being placed before Council again this evening for adoption. The applicant has requested that Council move ahead with the rezoning of the property from "Institutional" to "Business Park". A public meeting for both the official plan amendment and the zoning by-law amendment was held on May 4, 2011. The by-laws were prepared and passed later in the meeting.

6.4 Advanced Manufacturers Group – Deputy Mayor MacCafferty (verbal report)

Deputy Mayor MacCafferty provided an overview of her concerns regarding Mayor Thompson's failure to sign a cheque in the amount of approximately \$3,000.00, which was previously approved through the adoption of the 2011 Budget, for the Town's membership in the Advanced Manufacturing Group (part of the Ontario East Economic Development Commission). Discussion took place regarding how the Town of Deep River benefits from this membership and whether the Town should continue as a member. It was noted the Ontario East Economic Development Commission has since set their budget and reduced the amount for the nuclear sector due to Deep River's option not to participate with the Advanced Manufacturing Sector. Direction was given to staff to prepare a motion for debate later in the meeting.

6.5 Administration Monthly Report

Michelle Larose, CAO/Clerk, provided an overview of her report. Ms. Larose highlighted the summer arts camp attended by local youth and indicated a mural has been placed along the banister of the loft at Town Hall for the public to view the talent. Ms. Larose also noted the successful turnout for the 6 x 1 relay held recently.

Mayor Thompson introduced new Fire Chief Gene Thompson to Council and welcomed him to Deep River. Chief Thompson started his duties on July 18, 2011. Mayor Thompson also noted that the Town's new Accounts Clerk, Carole Hamelin, began her duties on July 18, 2011 as well.

6.7 Public Works Monthly Report

Khizar Hayat, Director of Public Works, provided an overview of his report. Discussion took place regarding the recent wind storm experienced by the municipality. Staff has recommended that tipping fees at the Miller Road landfill site be waived for residents who can deliver their tree debris to the site and Public Works can pick up debris at the curbside when time permits, for residents who can't deliver to the site. Direction was given to staff to prepare a motion for debate later in the meeting.
